Dear Parents,

As the school announces the formation of PTA body for the academic year 2026-27, it also expresses its gratitude and puts on record the support and co-operation received from the PTA body 2025-26 in all the activities of the school.

The formation of Parent-Teacher Association for the session 2026-27 will be as per the G.R. dated 21.03.2014 and Amendment issued by the Maharashtra Government as per the following schedule:

Date: 18th JULY 2026, Saturday

Registration Timings: 1.30 pm to 2.00 pm

Venue: Multipurpose Hall (3rd floor)

Guidelines:

- Parent of every student in the school shall be a member of the Parent-Teacher Association. An annual fee of Rs. 50/ shall be collected from each member of the Association.
- For giving representation to every standard, a lottery shall be conducted by drawing a lot of the willing parents of each standard to constitute the executive Committee.

The Executive Committee shall consist of:

- ❖ Chair Person – Principal
- ❖ Vice Chair Person – One amongst the Parents
- ❖ Joint Secretary - One amongst the Parents
- ❖ Secretary – One amongst the Teachers
- ❖ Joint Secretary - One amongst the Teachers
- ❖ Members – One Parent and One Teacher from every standard
- To be eligible for nomination to the post of Vice chairperson and Joint secretary (parent), your ward should have completed three years of schooling in DAV Public School, New Panvel.
- In the Executive Committee one member shall be from SC/ST/BC and 50% of PTA members shall necessarily be the female members.
- The term of the Executive Committee of the Parent-Teacher Association shall be for one Academic year and no member of the Executive Committee shall be eligible for drawing a lot by lottery within the period of three years since the formation of the Executive Committee.
- The committee shall meet at least once in three months.


Dear Parents kindly also note:

- a) To promote, maintain and develop opportunities for the harmonious development of students.
- b) To organize workshops and group discussions for the students on the topics connected with the education and development of the child.

- d) To assist the School and its staff in solving the general and individual problems of the children.
- e) To take cognizance of various fee rates like Tuition Fee, Term Fee, Annual Activity Charges, Lab Charges, Students Welfare Fund, etc.

Important Pointers:

- In working towards the objectives the PTA will be guided by the Management of the School and with the underlying principle of ensuring that all actions are in the best interest of the students without compromising the long-term interest of the school.
- The PTA will only confine itself to such activities as permissible under the objectives
- It would be distinctly understood that the PTA as well as its individual members shall scrupulously refrain from interfering with the day-to-day administration of the school
- 10% of PTA members must be present at the meeting to be able to conduct PTA business. PTA cannot proceed with an activity or program if there are not enough members present to vote on the proposal.
